The population includes all people who had temporary marriage and the statistical sample is 200 persons who have been selected by available sampling. The instrument of this research is a questionnaire made by researcher that has the acceptable validity and reliability. The methods of statistical analysis include mean, standard deviation, chi – square test, one – cities. The main purpose of this research is to explain temporary marriage as one predictive role in the crime area that... finally, it has been identified that there is a direct relationship between temporary marriage and pretention of crime against public decency. Temporary marriage is a Islamic principle that has benefits at the special conditions, this marriage like permanent marriage has conditions that we must conduct according to the rules and principle, unless we face to problem. Temporary marriage is one important issue that Shiite jurisprudence has paid attention to it.

Sexual perversion, drinking, drug addiction, smoking, murder, theft, political diversions and even diving accidents among single people are multi-times than married ones, as well as a variety of sexual diseases like syphilis, gonorrhea, AIDs and so an and mental diseases such as depression, anxiety. Among single people is higher than married people.

## The overall objective:

The overall objective of this research is to explain temporary marriage as preventive role in crime area.

## Research hypotheses:

- 1. There is a significant relationship between temporary marriage and the prevention of the crimes against public decency.
- 2. There is a significant different between the people who experienced temporary marriage and the people who didn't have temporary marriage according to committing crimes of crimes.

#### Public decency crimes:

Public decency crimes: all the actions that carries out against the legal rights of family, crimes that undermine the family survival and sanctity (such as: adultery and incest), crimes that threat family preservation and dignity (such as defamation, spreading lies and adultery rape), crimes that that undermine the stability of family relations (such as leave of charity.) and crimes that have negative effect an parentage and reproduction (Mehri, 2009)

In fact, committing the unlawful acts that according to the religions and customary rules, each one has a particular punishment is divided into 3 categories.

- A. Injuring public decency
- B. Violation of chastity
- C. Rape

#### Preventions of crimes and the status of judiciary in it

The purpose of this type of prevention is to safe the community in such to prevent the occurrence of the initial crime and also the recurrence of crime.

#### Situational crime prevention

This type of prevention will result along with the social prevention. This includes a set of actions and policies that tends to the domination on the environments and the situations surrounding crime and its inhibition.

#### The role of marriage in the prevention of marriage:

Sexual instinct not only can be the cause of artistic drawings but also caws some crimes. The various environmental, family and social factors originate from the type of sexual deviances.

Although some of these deviations are individual issues, but most of them have social combating with this class of injuries requires social fundamental change and it is necessary overall evolutions and precise planning's resolve them. By presenting social widespread teachings for people and families and resolving fundamental factors, these changes will be possible. This class of deviations often has close relation with other harms and sometime courses serious problems such as AIDS that relates to sexual deviations.

One of these strategies is to promote temporary marriage at social; it can prevent problems and issues (Yousefi, 2003).

#### MATERIALS AND METHODS

Analysis as the process of the scientific method is one of the fundamental bases of each methodology. In general, analysis includes the way in with the research process from the purpose of this research and description: in strategies is the population that is described by two ways, by census of all elements of society and computing parameters that descriptive statistics will be used such as statistical estimation and by pothouses test 10

#### **RESULTS AND DISCUSSION**

H1: there is a significant relationship between temporary marriage and prevention of crimes against public decency.

The result of data analysis showed that because the calculated chi-square is significant with freedom degree 3 at level 99%, therefore we can conclude that temporary marriage related to the prevention of crimes against 99% confidence that there is a significant relationship between temporary marriage and prevention of crimes against public decency. These results show that temporary marriage and its promoting at society can prevent crimes. Thus, this hypothesis is confirmed.

H2: there is a significant difference between the persons with a history of temporary marriage and those who have not experienced temporary marriage in terms of committing the crimes against public decency.

The result indicates that the calculated f (15, 10) with freedom degree 4 and 195 at level 99% is signification, namely according the temporary marriage experience. The results show that those who have not experienced temporary marriage, they have been more committed to the crimes against public decency.

H3: temporary marriage is a good predictor for social prevention of crime. The result indicated that the calculated chi-square (111, 80) is significant with freedom level 3 at level 99% therefore it can be concluded that temporary marriage can partially (46 percent) predict social prevention.

From these result it can be noted that one of the ways of organizations for prevention of crimes against public decency can be the promoting of temporary marriage can be one of the various models of social prevention. Therefore, the third hypothesis is confirmed.

#### **Discussion of results**

According to the results of hypotheses, it can be concluded that Iran population drive from traditional towards modern.

Thus, temporary marriage can be established at modern society.

The suitable patterns and advertisements can be effective to promote it. The existence of sexual desires in humans can't be denied and this need must be met by positive and constructive from. One of these constrictive routes can be temporary marriage that is justified according to religions rules and social norms and there is no legal or normative obstacle for it. We can refer to the direct relationship between prevention of crime and temporary marriage.

#### Research suggestions:

According to the confirmations of research hypotheses and the existence of significant relationship between variables, given that there was a correlation between variables, it is recommended:

- 1. Identifying mental needs and quality of meeting these needs are very effective at happiness and when they don't in to deviation.
- 2. Aware families to control more their children and alert them about the punishment of crimes.
- Coordinate public and private sectors that are active in the field of prevention of crimes: such as police, labar and social affairs, education, municipalities, councils, youth affairs, welfare so on to implement preventive action plans and more coordination.

Promote temporary marriage as a preventive solution of crimes against public decency and facilitate the culture of simple marriage.
