These structures and Deviations include the rise in childhood, postpone of social maturity, Lack of Responsibility, Sexual relations outside the rules because of classification in specific age groups, Escaping from school and the reluctance of the science due to forced and dictated curriculum and worth differences, sharing the experiences of juvenile delinquency due to reduced informal monitoring and control of community. And the long-term compulsory in schools, Facilitating the process of labeling and child mental frustration of dead-based evaluation system of certification.

Edwin Sutherland's preferred provider association theory suggests that criminal behavior occurs during interaction with other people, especially in intimate groups. Students spent a long time in the school and this is a favorable factor to the frequency, duration and intensify in their relationships(Williams and Mkshyn,2011).

Mechanical Socialization students in schools

Durkheim seem social reality as a phenomenon He believes that the adult generation have to impact through the education of children who are not yet ready for social life. as soon as selfish and anti-social person Should changed.(Durkheim,2008) This leads to the importance placed on top of the teacher instead of the student. At the same time teacher finds the role of preacher, supervisor and therapist .In each of these roles teacher stabilize his power(Illich,2010) The logical consequence of this view is that students do not face the problems alone. This is the most important factor in passive students. Social maturity should not be confused with cognitive maturity and intelligence Because people today receive knowledge much earlier than ancient societies in various social issues such as political, economic, family, work But this knowledge is not sufficient reason for social maturity Because social maturity entails engaging with social issues in addition to his readiness in accepting social responsibility. Behaviors such as indifference, negligence, extravagant, paying too much on entertainment and hobbies wasting time represents this issue. In the past, people from a very young age that had the ability to understand, start to work and enter to real problem And they were expected to cope with the tasks assigned.

Values and norms alien to the lower classes of society

Schools system in each country affected by the values and norms of upper classes and middle classes of the community hence According to the sociologists such as Durkheim, it is obviously that Society cannot be seen as a group of disparate and unrelated members to come together and It is necessary to create a collective psyche.((If the community is valuable And have already seen that our society is worth so It is necessary to educate the citizens for sharing thoughts and feelings and creating a united community . Society is impossible without it. thus to reach our goals, we need it. When education inherently is social responsibility therefore The government should not be indifferent to it. anything should be function of the government if it is related to education.)) (Durkheim,2008) But in the meantime, social classes and the public education system are at odds with the values and norms which mainly are from the lower classes of society .Classes that face with shortage in values and financial resources. According to Durkheim ,Children should be strict for passing through individual selfishness Although he explicitly states in his book that his purpose is not Corporal punishment but he resist to rigor .he believes that it is necessary for children to overcome their selfishness. Because in his view, adults make sacrifices to achieve their objectives in social relationships But the children have not the opportunity to achieve this experiences at this stage of their lives It is better to abandon the self-taught in the training process Until be able to live in comfort((Training will lead us to the fact that beyond our nature and in this case the child will be a man But with a painful attempt ,we reach the target . It is true that life is free from blur and dark But life is hard and difficult and Training that prepare one for it should not be ignored. It is necessary To achieve self-control, learning make harness his selfishness. So, to get children to exercise self-determination and control, pressure cannot be considered sufficient for the life of normal people.)) (Durkheim,2008).
