


Figure 1. Hierarchy of Environmental Sanfeld, Source: (Porteous, 1977)

• Gibson (Quote from Lang) makes a model in the year 1383 explain where the distinction among the three environmental components is specified:






Figure 4. Viewing and mental conflicts, the perception of the image Source: author.




Figure 5. Factors associated with attention, Source: author

In fact the perception, thoughts and perceptions, actions, and our work of memory originated and we feel the continuity. And that aspect of encoding, storage, retrieval process of perception.





Figure 6. after seeing and engaging memory Source: author.
